Covering 27.9 square miles, and home to about 24,400 residents, the Town of Windham is made up of the city of Willimantic, as well as boroughs of Windham Center, North Windham and South Windham in the quiet northeast corner of Connecticut.



The city of Willimantic was consolidated with the town in 1983. Originally occupied by Algonquian people (Pequot, Mohegan, Narragansett, and Nipmuck), Windham was left to settlers by Joshua Uncas, son of Uncas. The first town meeting was held in 1691.
